TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this “*Trademark Security Agreement*”) is made this 28th day of May, 2008, by and among WCI COMMUNITIES, INC., a Delaware corporation (the “*Grantor*”), and BANK OF AMERICA, N.A., a national banking association, in its capacity as collateral agent (the “*Collateral Agent*”) under that certain Collateral Agency Agreement dated April 30, 2007, as amended and restated by that certain Restated and Amended Collateral Agency Agreement dated as of October 1, 2007, as amended and restated by that certain Second Restated and Amended Collateral Agency Agreement dated as of January 16, 2008 (as the same may be further amended, restated, replaced, supplemented or otherwise modified from time to time, the “*Collateral Agency Agreement*”), for the benefit of the Revolving Credit Agent, on behalf of the Revolver Lenders (as such terms are defined below), and the Term Loan Agent, on behalf of the Term Loan Lenders (as such terms are defined below).

WITNESSETH:

WHEREAS, WCI Communities, Inc., a Delaware corporation (“*WCI*”), is a party to that certain Senior Revolving Credit Agreement dated as of June 13, 2006, as amended by that certain First Amendment to Credit Agreement dated as of April 5, 2007 (effective as of March 31, 2007), that certain Second Amendment to Credit Agreement dated as of August 17, 2007, and that certain Third Amendment to Credit Agreement dated as of January 16, 2008 (as heretofore, and as the same may hereafter be, amended, extended, renewed, restated or replaced, the “*Revolving Credit Agreement*”), by and among WCI, as borrower, the financial institutions from time to time party thereto as lenders (collectively referred to herein as the “*Revolver Lenders*”), Bank of America, N.A., as administrative agent for the Revolving Lenders (in such capacity, and together with any successor administrative agent appointed in accordance with the applicable terms of the Revolving Credit Agreement, the “*Revolving Credit Agent*”), Swing Line Lender and an L/C Issuer, Wachovia Bank, N.A., as Syndication Agent, Fifth Third Bank, KeyBank National Association and The Royal Bank of Scotland plc, as Co-Documentation Agents, and Banc of America Securities LLC, Wachovia Capital Markets LLC and RBS Securities Corporation, as Joint Lead Arrangers and Joint Book Managers; and

WHEREAS, WCI is also a party to that certain Senior Term Loan Agreement dated as of December 23, 2005, as amended by that certain First Amendment of Term Loan Agreement dated as of June 30, 2006, that certain Second Amendment of Term Loan Agreement dated as of April 5, 2007 (effective as of March 31, 2007), that certain Third Amendment of Term Loan Agreement dated as of August 17, 2007, and that certain Fourth Amendment of Term Loan Agreement dated as of January 16, 2008 (as heretofore amended, and as the same may be hereafter amended, extended, renewed, restated or replaced, the “*Term Loan Agreement*”), by and among WCI, as borrower, the financial institutions from time to time party thereto as lenders (collectively referred to herein as the “*Term Loan Lenders*”), KeyBank National Association, a national banking association, as the administrative agent for the Term Loan Lenders (in such capacity, the “*Term Loan Agent*”), Keybank Capital Markets, a division of KeyBank National Association, as Co-Lead Arranger and Sole Book Arranger, and Wachovia Capital Markets, LLC, as Co-Lead Arranger; and

WHEREAS, the Revolving Lenders and Term Loan Lenders are willing to make financial accommodations as provided for in the Revolving Credit Agreement and Term Loan Agreement, but only upon the condition, among others, that the Grantor shall have executed and delivered to the Collateral Agent, for the benefit of the Revolving Lenders and Term Loan Lenders, that certain Security Agreement dated as of April 30, 2007 and that certain Security Agreement dated as of October 16, 2007 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, collectively, the "*Security Agreement*");

WHEREAS, pursuant to the Security Agreement, the Grantor is required to execute and deliver to the Collateral Agent, for the benefit of the Revolving Lenders and Term Loan Lenders, this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. The Grantor hereby grants to the Collateral Agent, for the benefit of the Revolving Lenders and Term Loan Lenders, a continuing first priority security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "*Trademark Collateral*");

(a) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party including those referred to on Schedule I hereto;

(b) all reissues, continuations or extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and

(d) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademark licensed under any Intellectual Property License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Intellectual Property License.

3. SECURITY AGREEMENT. The security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the security interests granted to the Collateral Agent, for the benefit of the Revolving Lenders and Term Loan Lenders, pursuant to the Security Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. AUTHORIZATION TO SUPPLEMENT. If the Grantor shall obtain rights to any new trademarks, the provisions of this Trademark Security Agreement shall automatically apply thereto. The Grantor shall give prompt notice in writing to the Collateral Agent with respect to any such new trademarks or renewal or extension of any trademark registration. Without limiting the Grantor's obligations under this Section 4, the Grantor hereby authorizes the Collateral Agent unilaterally to modify this Agreement by amending Schedule I to include any such new trademark rights of the Grantor. Notwithstanding the foregoing, no failure to so modify this Trademark Security Agreement or amend Schedule I shall in any way affect, invalidate or detract from the Collateral Agent's continuing security interest in all Trademark Collateral, whether or not listed on Schedule I.

5. COUNTERPARTS. This Trademark Security Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. In proving this Trademark Security Agreement or any other Loan Document in any judicial proceedings, it shall not be necessary to produce or account for more than one such counterpart signed by the party against whom such enforcement is sought. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.

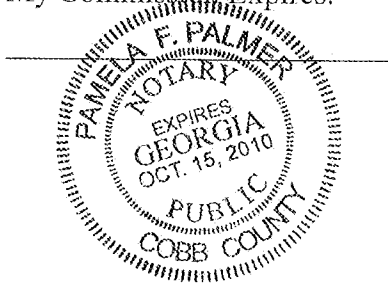
