## TRADEMARK SECURITY AGREEMENT

### RECITALS

WHEREAS, Secured Party has loaned certain funds to Grantor (the "Loan"); and

WHEREAS, Grantor is willing to secure repayment of the Loan through its grant of the security interest set forth herein, and Secured Party wishes to accept such security interest,

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:



Grantor hereby grants to Secured Party, and Secured Party hereby accepts from Grantor, a security interest in and to Grantor's right, title and interest in and to the trademarks and trademark registrations listed on Exhibit "A" attached hereto, and the goodwill of the business connected therewith and symbolized thereby.

2. The security interest created by this instrument shall automatically terminate upon repayment of the Loan. Notwithstanding the foregoing, Secured Party shall execute and deliver such documents, and perform such acts, as are reasonably requested by Grantor in order to confirm or memorialize such termination. Secured Party hereby appoints Grantor as Secured Party's duly authorized attorney-in-fact to execute and deliver such documents and to perform such acts in the name and on behalf of Secured Party, in the event that Secured Party fails or refuses to do so, for any reason or for no reason. Such appointment is irrevocable and coupled with an interest.


