TERMINATION OF SECURITY INTEREST AND RELEASE

This Termination of Security Interest and Release (this "Termination and Release") is made as of this 11 day of December, 2007 by **Bank of America, N.A.**, a Delaware Association, with offices located at One S. Wacker Drive, Suite 3400, Chicago, Illinois 60606 (hereinafter "Secured Party") and **Fire King International, LLC.**, an Indiana limited liability company, with offices located at 101 Security Parkway, New Albany, Indiana 47150; **Fire King Security Products, LLC**, an Indiana limited liability company, with offices located at 101 Security Parkway, New Albany, Indiana 47150; and **Image Vault, LLC**, an Indiana limited liability company, with offices located at 101 Security Parkway, New Albany, Indiana 47150 (hereinafter collectively, "Borrowers").

RECITAL:

A. Pursuant to the Patent Assignments and Trademark Assignments listed in Schedule A (hereinafter the "Security Assignments"), by and between the Secured Party and GE Business Capital Corporation (f.k.a. Transamerica Business Capital Corporation), a Delaware Corporation, with offices located at 500 W. Monroe, Chicago, Illinois 60661 (hereinafter "Agent"), the Agent assigned Agent's security interest in all of the Patents listed in the attached Schedule B (hereinafter the "Patents") and Trademarks listed in the attached Schedule C (hereinafter the "Trademarks") to the Secured Party.

B. Pursuant to the Security Agreements listed in Schedule D, by and between the Agent, as Agent for lenders party and any and all other lending institutions (hereinafter collectively "Lenders"), and Borrowers and/or Borrowers' predecessors (NKL Industries, LTD., Meilink Safe Company, and Fire King International, Inc.), the Agent received a security interest in all of the Patents

and Trademarks.

C. Secured Party has agreed to terminate its security interest in all of the Patents and Trademarks set forth in Schedule B and Schedule C, release and waive any claim Secured Party may have, and release all of its right, title and interest in each of the Patents and Trademarks as herein provided and as provided in the Security Assignments and the Security Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Secured Party hereby terminates its security interest in the Patents and Trademarks and releases any and all claims, liens, security interests or encumbrances thereto and rights therein. Secured Party hereby assigns and transfers to the Borrowers, without recourse, all of the Secured Party's right, title and interest in and to each of the Patents and Trademarks and any and all related applications or registrations to the Patents and Trademarks, as of the date set forth above.

2. This Termination and Release shall inure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.

3. This Termination and Release may be executed in two or more counterparts, each of which shall be deemed an original, but all of which shall constitute the same agreement. The execution of a counterpart of the signature page to this Termination and Release shall be deemed the execution of a counterpart of this Termination and Release. The delivery of this Termination and Release may be made by facsimile, and facsimile signatures shall be treated as original signatures for all applicable purposes.
