TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as June 11, 2008, by and among GOODY'S FAMILY CLOTHING, INC. ("Goody's"), a Tennessee corporation, GFC AIRCRAFT HOLDINGS, INC. ("GFC Aircraft Holdings"), a Tennessee corporation, GFC PROFESSIONAL SERVICES, LLC ("GFC Professional Services"), a Tennessee limited liability company, SYDOOG LLC ("SYDOOG"), a Delaware limited liability company, ISDE, INC. ("ISDE"), a New York corporation, TREBOR OF TN, LLC ("Trebor"), a Tennessee limited liability company, GOFAMCLO LLC ("GOFAMCLO"), a Delaware limited liability company, GOODY'S GIFTCO, LLC ("Goody's Giftco"), a Virginia limited liability company, GFC AIRCRAFT LEASING, LLC ("GFC Aircraft Leasing"), a Delaware limited liability company, GFC AIRCRAFT MANAGEMENT, LLC ("GFC Aircraft Management"), a Tennessee limited liability company, GFCFS, LLC ("GFCFS"), a Delaware limited liability company, GOODY'S MS, L.P. ("Goody's MS"), a Tennessee limited partnership, GFCTX, L.P. ("GFCTX"), a Tennessee limited partnership, GOODY'S IN, L.P. ("Goody's IN"), a Tennessee limited partnership, GFCTN, L.P. ("GFCTN"), a Tennessee limited partnership, GFCGA, L.P. ("GFCGA"), a Tennessee limited partnership, GOODY'S HOLDING TN, LLC ("Goody's Holding TN"), a Tennessee limited liability company, GOODY'S TNDC, L.P. ("Goody's TNDC"), a Tennessee limited partnership, GOODY'S ARDC, L.P. ("Goody's ARDC"), a Tennessee limited partnership, GOODY'S RETAIL MS, L.P., a Tennessee limited partnership ("Goody's Retail MS" and together with Goody's, GFC Aircraft Holdings, GFC Professional Services, SYDOOG, ISDE, Trebor, GOFAMCLO, Goody's Giftco, GFC Aircraft Leasing, GFC Aircraft Management, GFCFS, Goody's MS, GFCTX, Goody's IN, GFCTN, GFCGA, Goody's Holding TN, Goody's TNDC, and Goody's ARDC, each individually a "Borrower" and, collectively, the "Borrowers"), and each other party as shall from time to time become a party hereto (such other parties, together with the Borrowers, each individually, as a "Grantor" and, collectively, as the "Grantors"), and PGDYS LENDING LLC, a Delaware limited liability corporation ("Agent"), individually as a Lender and in its capacity as Agent for Lenders party to the Credit Agreement (as hereinafter defined).

WITNESSETH:

WHEREAS, pursuant to that certain Senior Secured, Super-Priority Debtor-in-Possession Credit Agreement dated as of the date hereof by and among Borrowers, the Persons named therein as Credit Parties, Agent and the Persons signatory thereto from time to time as Lenders (including all annexes, exhibits and schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement"), Lenders have agreed to make the Loans for the benefit of Borrowers;

WHEREAS, each Grantor is a debtor-in-possession in the Chapter 11 Cases and wishes to continue to operate its business and manage its property as debtor and debtor-in-possession pursuant to Sections 1107(a) and 1108 of the Bankruptcy Code;

WHEREAS, Agent and Lenders are willing to make the Loans pursuant to the terms and conditions of the Credit Agreement and the Interim Order (or Final Order when applicable), but only upon the condition, among others, that each Grantor shall have executed and delivered to Agent, for itself and the ratable benefit of Lenders, that certain Security Agreement

dated as of the date herewith (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, each Grantor is required to execute and deliver to Agent, for itself and the ratable benefit of Lenders, this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement, the Credit Agreement or in Annex A thereto.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Each Grantor hereby conveys and pledges to Agent, for itself and the benefit of Lenders, a security interest in and a Lien upon all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

(a) all of its Trademarks, and Trademark Licenses to which it is a party, including those Trademarks referred to on Schedule I hereto;

(b) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(c) all Proceeds of the foregoing, including (to the extent covered in the defined term "Proceeds"), without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License;

provided, that Trademark Collateral shall not include (i) avoidance actions under Sections 502(d), 544, 545, 547, 548, 551, 553(b), 732(2) or 742(2) of the Bankruptcy Code and the proceeds thereof, and (ii) any directly held investment property or any general intangibles, now or hereafter held or owned by any Grantor, to the extent, in each case, that (a) a security interest may not be granted by such Grantor in such directly held investment property or general intangibles (including applications filed in the U.S. Patent and Trademark Office to register trademarks or service marks on the basis of any Grantor's "intent to use" such trademarks or service marks) as a matter of law, or under the terms of the governing document applicable thereto, without the consent of one or more applicable parties thereto and (b) such consent has not been obtained; provided, however that Trademark Collateral shall include (x) any and all proceeds of such directly held investment property or general intangibles to the extent that the proceeds are not themselves directly held investment property or general intangibles subject to the immediately preceding proviso in this Section 2 and (y) upon any such applicable party or

parties' consent (and in the case of applications filed in the U.S. Patent and Trademark Office to register trademarks or service marks on the basis of any Grantor's "intent to use" such trademarks or service marks, the filing and acceptance of a "Statement of Use" or "Amendment to Allege Use") with respect to any otherwise excluded directly held investment property or general intangibles being obtained, thereafter such directly held investment property or general intangibles.

3. SECURITY AGREEMENT. The security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the security interests granted to Agent, on behalf of itself and Lenders, pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of irreconcilable differences between this Agreement and the Security Agreement, the terms of the Security Agreement shall control.

4. THE ORDER. The Security Interest provided for in this Agreement has also been granted pursuant to the Interim Order (or Final Order, when applicable). This Agreement supplements the Interim Order (or Final Order, when applicable) without in any way diminishing or limiting the effect of the Interim Order (or Final Order, when applicable) or any Lien or security interest granted thereunder.

5. ADDITIONAL GRANTORS. Other Persons may hereafter become parties to this Agreement (each an "Additional Grantor") by executing a supplement or counterpart hereof, in each case, in form and substance satisfactory to Agent, and there shall be no need to re-execute, amend or restate this Agreement in connection therewith. Upon such execution and delivery by any Additional Grantor, such Additional Grantor shall be deemed to have made the representations and warranties set forth herein, and shall be bound by all of the terms, covenants and conditions hereof to the same extent as if such Additional Grantor had executed this Agreement as of the Closing Date, and the Agent, for itself and the benefit of the Agent, shall be entitled to all of the benefits of such Additional Grantor's obligations hereunder.

6. TERMINATION OF THIS SECURITY AGREEMENT. This Agreement shall terminate upon the Termination Date.


