PATENT AND TRADEMARK RELEASE

THIS INTELLECTUAL PROPERTY RELEASE (this “**Release**”) is made as of November 5, 2007, by General Electric Capital Corporation, as agent (“**Agent**”).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement and that certain Patent Security Agreement each dated as of May 15, 2003, that certain Amended and Restated Trademark Security Agreement and that certain Amended and Restated Patent Security Agreement each dated as of August 9, 2004, that certain Amended and Restated US Security Agreement dated as of August 9, 2004 and that certain Trademark Security Agreement dated as of December 30, 2005 (collectively, the “**Security Agreement**”), Blount, Inc. and Omark Properties, Inc. (collectively, the “**Companies**”), have granted to Agent a security interest in the Patents set forth in Schedule 1 (the “**Patents**”) and the Trademarks set forth in Schedule 2 (the “**Trademarks**”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on May 21, 2003, September 1, 2004 and January 12, 2006, with the Trademarks recorded at Reel 002736, Frame 0172, Reel 003043, Frame 0235 and Reel 003225, Frame 0698 and the Patents recorded at Reel 014051, Frame 0753 and Reel 016360 and Frame 0440;

WHEREAS, the Companies have entered into that certain Asset Purchase Agreement, dated as of November 5, 2007, by and among the Companies, certain subsidiaries of Blount, Inc., Blount International, Inc., Caterpillar Forest Products Inc., Caterpillar Inc. and certain subsidiaries of Caterpillar Inc., whereby the Companies have agreed to sell certain of its assets, including without limitation, the Patents and the Trademarks; and


WHEREAS, the Companies have requested that Agent release its lien on the Patents and Trademarks;
