## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is entered into as of this 20th day of June, 2008 by and among BP p.l.c., a United Kingdom public limited company, having its principal office and place of business at 1 St. James's Square, London, SW1Y 4PD ("Assignor"), and Multi Service Corporation, a Missouri corporation, having its principal office and place of business at 8650 College Boulevard, Overland Park, Kansas 66210 ("Assignee").

WHEREAS, Assignor owns (i) the application for ALTIVIS as set forth in European Community Trade Mark (CTM) No. 006543334 and (ii) the application for ALTIVIS as set forth in United States Patent and Trademark Office Application No. 77/379,814 (collectively, the "Marks") (all as set forth on Exhibit A) and any common law rights that have accrued in the ALTIVIS mark in the United States or elsewhere.

WHEREAS, pursuant to Section 21.1 of the Sea Card Processing Services Agreement between the parties, Assignor wishes to assign to Assignee all of Assignor's right, title and interest in the use of the Marks, subject to the terms and conditions hereof; and

WHEREAS, Assignee desires to acquire the entire right, title and interest in and to said Marks, and the related registrations or applications (collectively, the "Trademark Rights").

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. For the consideration of \$10.00, Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest in and to the Trademark Rights, together with that portion of the goodwill related to the Trademark Rights connected with the use of and symbolized by the trademarks included in the Trademark Rights, all common law rights and all causes of action, past, present and future for infringement of the Trademark Rights.

2. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect the title to the Trademark Rights in Assignee, its successors and assigns, and that it will, at any time upon request, communicate to Assignee, its successors and assigns, such facts relating to the Trademark Rights or the history thereof as may be known to it.
