
In consideration of the payment of all indebtedness and amounts secured by that certain Trademark Security Agreement made as of March 1, 2001, by and between TD Bank, N.A., formerly known as TD Banknorth, N.A., formerly known as Banknorth, N.A. successor-by-merger to Boston Federal Savings Bank, with a principal place of business at 17 New England Executive Park, Burlington, MA 01803 (the "**Bank**"), and Brigham's, Inc., a Massachusetts corporation, with a principal place of business at 30 Mill Street, Arlington, MA 02476 (the "**Borrower**"), which Trademark Security Agreement was filed with the United States Patent and Trademark Office on July 27, 2001, and recorded in Reel 2338, Frame 0780, et seq., of the Trademark Assignment Records, the Bank hereby releases and discharges all of its right, title and interest in and to the above-described Trademark Security Agreement, including the security interest and conditional assignment created and existing thereunder on the property described in and covered thereby, and reassigns to the Borrower any right, title and interest of the Bank in and to the "Collateral" described therein, including the right to recover for past infringement of any of the Collateral and the goodwill of the goodwill of the business in connection with which the Collateral is used and which is symbolized by any of the Collateral.
