## TERMINATION OF PATENT AND TRADEMARK SECURITY AGREEMENT

This Termination of Patent and Trademark Security Agreements (this "Termination"), dated as of June 30, 2008, is executed by Bank of America, N.A. ("Secured Party"), 800 5th Avenue, 17th Floor, WA1-501-17-32, Seattle, WA 98104-3176, in favor of CNET Networks, Inc., a Delaware corporation (the "Company"), 235 Second Street, San Francisco, CA 94105.

### RECITALS

WHEREAS, the Company, certain Lenders and Secured Party, as Administrative Agent, Swing Line Lender and L/C Issuer, entered in a certain Credit Agreement, dated as of October 12, 2007 (the "Credit Agreement"); and

WHEREAS, in connection with the Credit Agreement, the Company and Secured Party entered into certain Patent and Trademark Security Agreements dated as of October 12, 2007 ("Security Agreement 1") and dated as of March 21, 2008 ("Security Agreement 2" and collectively referred to herein as, the "Security Agreements"); and

WHEREAS, pursuant to the Security Agreements, the Company granted to Secured Party a security interest in certain "Collateral" including certain patents and trademarks; and

WHEREAS, the Credit Agreement and the Security Agreements have been terminated.

NOW, THEREFORE, Secured Party agrees as follows:

1. Secured Party is executing and delivering this Termination as further evidence of the termination of the Security Agreements.

2. Secured Party claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Security Agreements, and, accordingly, Secured Party expressly terminates its security interest in (i) the patents and trademarks listed on Exhibit A and Exhibit B hereto, which security interest was evidenced by the recordation of the Security Agreement 1 with the United States Patent and Trademark Office on October 23, 2007 in Reel/Frame 020001/0643 and (ii) the patent listed on Exhibit C hereto, which security interest was evidenced by the recordation of the Security Agreement 2 with the United States Patent and Trademark Office on and March 24, 2008, in Reel/Frame 020691/0504.
