TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT dated June 30, 2008, made by M. P. PUMPS, INC., a Michigan corporation (the "Grantor"), and FIRSTRUST BANK (together with any successor thereto, the "Grantee"), a national banking association duly organized and validly existing under the laws of the United States of America.

M. P. PUMPS, INC., MP PUMPS ACQUISITION CORP. and Grantee have entered into a certain Loan Agreement dated the date hereof (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"). Capitalized terms not otherwise defined herein shall have the same meanings as specified therefor in the Loan Agreement or the Security Agreement referred to below.

In connection with the Loan Agreement, the Grantor and the Grantee entered into a Security Agreement dated the date hereof (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which Grantor has granted to the Grantee a lien on and security interest in, inter alia, all of Grantor's right, title, and interest in and to all Trademarks (as defined in the Security Agreement) of each Grantor, whether then owned or thereafter acquired or created by Grantor, including, without limitation, the trademarks and trademark applications listed on Schedule A hereto (the "Trademark Collateral").

The parties desire to record Grantor's grant of the security interest in the Trademark Collateral to the Grantee with the United States Patent & Trademark Office.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees with the Grantee as follows:


A. The Loan Agreement and Security Agreement and their terms and provisions are incorporated herein in their entirety.

B. Grantor grants to the Grantee a lien on and security interest in all of its right, title and interest in and to the Trademark Collateral and the goodwill of the business symbolized by the Trademark Collateral.


