ASSIGNMENT OF TRADEMARKS

WHEREAS, Kerotest Manufacturing Corp., a Pennsylvania corporation (the "Assignee"), has adopted, used, is using and is the owner of the trademarks identified on Exhibit A attached hereto and made a part hereof which are now registered in the United States Patent and Trademark Office (the "Registered Trademarks"); and

WHEREAS, PNC Bank, National Association, a national banking association (the "Assignor"), provided to the Assignee a \$6,000,000 revolving credit facility and that was issued for the benefit of PNC Bank, National Association, as Trustee, a letter of credit in the amount of \$3,298,100 (together the "Credit Facilities") and required that the Registered Trademarks be assigned in 1994 to the Assignor as collateral security for the Credit Facilities.

WHEREAS, Assignee assigned the Registered Trademarks to Assignor on December 22, 1994.

WHEREAS, Assignee has closed the revolving credit facility associated with the Credit Facilities and Assignor no longer has any obligations to honor the letter of credit under the Credit Facilities, Assignor has no need for collateral security under the Credit Facilities.

The Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment of Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor hereby assigns and transfers to the Assignee, as collateral security for the Credit Facilities, without recourse and with no representations or warranties other than as set forth in the paragraph immediately above wherein Assignor has covenanted that no assignment, sale, agreement or encumbrance has or will be made or entered into by Assignor which would conflict with this Assignment of Trademarks, together with the goodwill of the Assignor's business symbolized by the Registered Trademarks and the registrations thereof.


