TRADEMARK RELEASE

THIS TRADEMARK RELEASE, dated as of this 27th day of June, 2008, given by Bank of America, N.A., as Second-Lien Collateral Agent, (the "Assignor") with principal offices at Mailcode NC1-001-15-04, 101 North Tryon Street, Charlotte, NC 28255, to Hawker Powersource, Inc., a Delaware corporation (together with any successors-in-interest to the Marks, the "Assignee"), having an address at 617 North Ridgeview Drive, Warrensburg, MO 64093, as follows:

WHEREAS, the Assignor wishes to release its security interest and restore all right, title and interest in and to the Trademark Collateral to the Assignee and to dissolve any and all liens and encumbrances respecting the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor hereby releases and discharges its security interest, and quit claims, reconveys, and relinquishes unto the Assignee all of its right, title and interest, in the Trademark Collateral granted to Assignor by the Assignee pursuant to the Trademark Security Agreement, which Trademark Security Agreement was duly recorded on April 6, 2004, at Reel/Frame 2945/0167 in the United States Patent and Trademark Office.

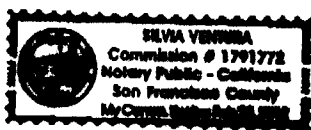

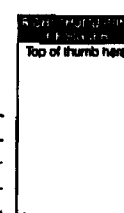
