IP SUPPLEMENT

This IP SUPPLEMENT (this "Supplement") dated as of July 14, 2008 is delivered pursuant to and supplements the Trademark Security Agreement dated as of November 8, 2006 (said Trademark Security Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Trademark Security Agreement"), among Neways, Inc. a Utah corporation ("Neways"), LTM Enterprises, Inc., a Nevada corporation (the "Borrowers") and Neways Japan, Inc., a Nevada corporation ("Neways Japan" and together with Neways and the Borrower, the "Pledgors"), and Silver Point Finance, LLC, in its capacity as Collateral Agent ("Collateral Agent") Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Trademark Security Agreement.
