RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of July 25, 2008 by GOLDMAN SACHS CREDIT PARTNERS L.P. ("GSCP"), as Second Lien Collateral Agent for the Secured Parties (the "Second Lien Collateral Agent"), in favor of Stolle Machinery Company, LLC ("Stolle"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed in the Security Agreement (as defined below).

WITNESSETH

WHEREAS, Second Lien Collateral Agent, Lenders, and Stolle are parties to (i) a certain Credit Agreement, dated as of September 29, 2006 (the "Credit Agreement"), (ii) a certain Assumption Agreement dated September 29, 2006 (the "Assumption Agreement"), and (iii) a certain Second lien Trademark Security Agreement dated as of September 29, 2006 (the "Trademark Security Agreement"), pursuant to which Stolle has granted a security interest in and continuing lien on all of Stolle's right, title, and interest in, to, and under all the assets to certain trademarks as security for the Obligations, including the trademarks set forth on Schedule A hereto; and

WHEREAS, the Second Lien Trademark Security Agreement was recorded in the United States Patent and Trademark Office on October 31, 2006 at Reel/Frame No. 3419/0299;

WHEREAS, Stolle has requested that the Second Lien Collateral Agent release its security interest in the Trademark Collateral (as such term is defined herein below) and reassign the same to Stolle;

NOW, THEREFORE, for good and valuable consideration, receipt, and sufficiency of which is hereby acknowledged:

<u>SECTION 1</u>. The Second Lien Collateral Agent hereby terminates and releases its security interest in and continuing lien on all of Stolle's right, title and interest in, to, and under all of the following assets (all of which being hereinafter referred to as the "Trademark Collateral"):

(a) all (i) United States and foreign trademarks, trade names, trade dress, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certification marks, collective marks, logos, and other source or business identifiers, designs and general intangibles of a like nature owned by Stolle, all registrations and applications for any of the foregoing including, but not limited to, the registrations and applications referred to in Schedule A hereto (as such schedule may be amended or supplemented from time to time), (ii) extensions or renewals of any of the foregoing, (iii) goodwill of the business connected with the use of and symbolized by the foregoing, (iv) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill, (v) proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit, and (vi) rights corresponding thereto throughout the world.

<u>SECTION 2</u>. <u>FURTHER ASSURANCES</u>. Second Lien Collateral Agent agrees to promptly provide Stolle with any information and additional authorization, and will promptly execute any

documents necessary to effect, record, and perfect the release of the Second Lien Collateral Agent's security interest in the Trademark Collateral.

<u>SECTION 3</u>. <u>COUNTERPARTS</u>. This Agreement may be executed in any number of counterparts and by the parties hereto on separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.
