
RELEASE OF SECURITY INTERESTS IN TRADEMARK

FOR VALUE RECEIVED, the undersigned, **BANK OF AMERICA, N.A.**, a national banking association, as collateral and administrative agent (in such capacity, "Administrative Agent") for itself and various financial institutions, does hereby sell, assign, transfer and convey to **INFRA-METALS CO.**, a Georgia corporation (the "Company"), **without any representation or warranty by, or recourse to, Administrative Agent**, all right, title and interest of Administrative Agent in and to the trademark described on Schedule A attached hereto (the "Released Trademark"), arising under that certain Amended and Restated Trademark Security Agreement dated May 9, 2006, between the Company and Administrative Agent (as at any time amended, restated, supplemented or otherwise modified, the "Trademark Security Agreement") recorded on May 10, 2006, at Reel No. 3306, Frame 200, United States Patent and Trademark Office, together with the goodwill of the business symbolized by the Released Trademark.

The aforesaid assignment is intended to operate as a release of Administrative Agent's liens upon and security interests in solely the Released Trademark, as conveyed by the Company to Administrative Agent pursuant to the terms of the Trademark Security Agreement, and to reassign to the Company all of Administrative Agent's right, title, and interest in the Released Trademark acquired pursuant to the terms of such Trademark Security Agreement.

IN WITNESS WHEREOF, Administrative Agent has caused this Release of Security Interests in Trademark to be signed by its duly authorized officer on August 1st, 2008.
