## NOTICE OF ASSIGNMENT

This Notice of Assignment (this "Notice") is executed and delivered as of August 6, 2008 by Bank of America, N.A. as assignor (the "Assignor") and Comerica Bank, as assignee (the "Assignee").

The Assignor has resigned as Administrative Agent under and pursuant to that certain Amended and Restated Credit Agreement dated as of July 18, 2005 by and among Industrial Distribution Group, Inc. ("IDG"), IDG USA, LLC ("IDG USA" and together with IDG, each a "Borrower" and collectively, the "Borrowers"), certain financial institutions party thereto and the Assignor (as amended, the "Credit Agreement") and the Assignee has been appointed as the successor Administrative Agent under the Credit Agreement in each case pursuant to the terms of that certain Omnibus Assignment and Acceptance Agreement dated as of August 6, 2008 (the "Assignment Agreement"). As set forth in the Assignment Agreement, the Assignor has assigned all of the liens that secure the obligations of the Borrowers (and any guarantor) under the Credit Agreement to the Assignee, including all liens granted under and pursuant to that certain Amended and Restated Trademark Security Agreement dated as of July 18, 2005 executed and delivered in connection with the Credit Agreement.


