We write, on behalf of Ventura Foods, LLC, the current owner of the above listed registration, to request that the following merger be recorded against RN 69,456 for the mark KO-NUT.

The merger documents were previously filed with the U.S. Patent and Trademark Office for recordation against KO-NUT (RN 69,456). (See Reel / Frame 0760 / 0448, filed December 6, 1990). However, due to a typographical error, the KO-NUT registration number was improperly identified on the Assignment schedule as “RN 691,436” rather than RN 69,456. Due to this typographical error, the merger of DIF Corp. into Conopco, Inc. was not recorded against the KO-NUT registration (RN 69,456).

The merger clearly intended to reference the KO-NUT registration, as is evidenced by the schedule, which clearly and accurately identifies the mark. The original parties – DIF Corp. and Conopco, Inc. are unavailable to correct to the assignment. However, Ventura Foods, LLC, the current, uncontested owner of the

KO-NUT registration, affirms that the this merger should be recorded against KO-NUT RN 69, 456.



SECOND: The surviving corporation is Conopco, Inc. (the "Surviving Corporation").

THIRD: The designation of the two classes of outstanding shares of Conopco is as follows:
