**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of August 21, 2008, is made by BEAR STEARNS CORPORATE LENDING INC., as Administrative Agent (the "Administrative Agent") for the banks and other financial institutions or entities (the "Lenders"), pursuant to the termination of the Credit Agreement, dated as of August 2, 2004 by and among Allied Security Holdings LLC, a Delaware limited liability company (the "Borrower"), the Lenders, the Syndication Agent party thereto, the Co-Documentation Agents party thereto and the Administrative Agent, and the other Secured Parties (as from time to time amended, restated, supplemented or otherwise modified and in effect from time to time, the "Credit Agreement"). Capitalized terms used herein but not otherwise defined herein have the meanings ascribed to them in the Credit Agreement.

W I T N E S S E T H

WHEREAS, under the terms of the Credit Agreement, the Borrower granted, to the Administrative Agent, a security interest in and continuing lien on all of its right, title and interest in, to and under certain property and other assets of the Borrower, including Patent Collateral, Trademark Collateral, and Copyright Collateral (each as defined below);

WHEREAS, pursuant to the Credit Agreement, the Borrower executed the Guarantee and Collateral Agreement by and among the Borrower and the Administrative Agent for the Secured Parties, dated August 2, 2004, pursuant to which the Borrower granted to Administrative Agent a security interest in and continuing lien on all the Borrower's right, title and interest in, to and under all Patents (the "Patent Collateral");

WHEREAS, pursuant to the Credit Agreement, the Borrower executed the Guarantee and Collateral Agreement by and among the Borrower and the Administrative Agent for the Secured Parties, dated August 2, 2004 and recorded with the U.S. Patent and Trademark Office on August 3, 2004 at Reel/Frame Nos. 3031/0554, 3040/0039, 3040/0378, and 3040/0102, pursuant to which the Borrower granted to Administrative Agent a security interest in and continuing lien on all the Borrower's right, title and interest in, to and under all Trademarks (the "Trademark Collateral");

WHEREAS, pursuant to the Credit Agreement, the Borrower executed the Guarantee and Collateral Agreement by and among the Borrower and the Administrative Agent for the Secured Parties, dated August 2, 2004 and recorded with the U.S. Copyright Office on October 15, 2004 at Volume 3516 Document No. 121, pursuant to which the Borrower granted to Administrative Agent a security interest in and continuing lien on all the Borrower's right, title and interest in, to and under all Copyrights (the "Copyright Collateral"); and

WHEREAS, in connection with the Borrower's satisfaction of all of its obligations under the Credit Agreement, the Guarantee and Collateral Agreement has been terminated.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby agrees as follows:

The Administrative Agent hereby terminates, discharges, releases, transfers and assigns, without recourse, unto the Borrower, all of its security interest and lien on all of the Borrower's right, title and interest in, to and under the Patent Collateral, Trademark Collateral, and the Copyright Collateral, including the patents and patent applications, the trademark and service mark registrations, and the copyright registrations listed on Schedule I attached hereto and incorporated herein by reference (collectively, the "Released Collateral"), and any right, title or interest of the Administrative Agent in such Released Collateral shall hereby cease and become void.

The Administrative Agent authorizes the recordation of this Release with the United States Patent and Trademark Office and the United States Copyright Office and any other applicable registry, the filing of Uniform Commercial Code financing statements and the filing or recording of any other document or instrument necessary to place on record the release of the Agent's Lien upon and security interest in the Patent Collateral, the Trademark Collateral, and the Copyright Collateral by the Borrower or any person authorized or designated by the Borrower, and any such recordation or filing shall be deemed to have been authorized by the Administrative Agent.

The Administrative Agent agrees to provide the Borrower with any additional authorization necessary and to do such other acts as may be reasonably necessary to effect the release of its security interest in the Released Collateral.

IN WITNESS WHEREOF, the Administrative Agent has executed this Release as of the date first set forth above.
