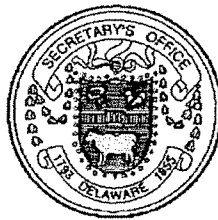

NAME

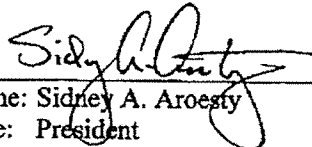
The name of the Corporation is Siemens Medical Solutions Diagnostics Corp. (the "Corporation").
