## INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT ("Assignment") is effective as of February 19, 2008 (the "Effective Date") by and between Morton International, Inc., having an office at 123 North Wacker Drive, Chicago, Illinois, 60606, United States of America, an Indiana corporation ("Morton"), and Martin Marietta Magnesia Specialties, LLC, a Delaware limited liability company having an office at 195 Chesapeake Park Plaza, Suite 200, Baltimore, Maryland, 21220 ("MMMS").

Effective as of the Effective Date, Morton hereby assigns, transfers and conveys to MMMS, to be held and enjoyed by MMMS for its own use and benefit and for its successors and assigns as the same would have been held by Morton had this Assignment not been made, all right, title and interest in and to the IP shown in the Exhibit attached hereto, including, without limitation, all reissues, divisions, continuations, continuations-in-part, extensions thereof, and supplementary protection certificates related thereto as applicable.

Morton and MMMS shall each take, and shall cause their respective Affiliates to take, any and all additional actions as may be necessary or appropriate to effect the transactions contemplated by this Assignment. Such actions may include, without limitation, the execution of additional documents to record the assignments and transfers made in this Assignment and the filing of such documents with the appropriate domestic and foreign governmental authorities.

Subject to applicable law, this Assignment may be amended, modified and supplemented by written instrument authorized and executed by MMMS and Morton at any time with respect to any of the terms contained herein. No waiver by any party hereto of any provisions hereof shall be effective unless explicitly set forth in writing and executed by the party so waiving. The waiver by either party hereto of a breach of any provisions of this Assignment shall not operate or be construed as a waiver of any other or subsequent breach.

This Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed, and delivered shall be an original, but all such counterparts shall together constitute one and the same instrument.
