## ASSIGNMENT OF CINCINNATI TRADEMARKS

This Assignment of Trademarks (this "*Assignment*") is made as of November 30, 2007 by CBS Radio Stations Inc., a Delaware corporation ("*Assignor*"), to Entercom Cincinnati, LLC, a Delaware limited liability company ("*Assignee*").

WHEREAS, Assignor, with a place of business at 1515 Broadway, 46<sup>th</sup> Floor, New York, New York 10036, is the owner of registrations for the trademarks that are identified in Schedule A ("*Marks*") and desires to assign all of its right, title and interest in, to and under the Marks, together with the goodwill and business symbolized thereby;

WHEREAS, Assignee, with a place of business at 401 City Avenue, Suite 809, Bala Cynwyd, Pennsylvania 19004, desires to obtain all of Assignor's rights in, to and under the Marks; and

WHEREAS, pursuant to that certain Asset Purchase Agreement (the "*Purchase Agreement*"), dated as of August 18, 2006, among Assignor, CBS Radio Inc. of Illinois, a Delaware corporation, Texas CBS Radio L.P., a Delaware limited partnership, and Assignee's corporate parent, Entercom Communications Corp., a Pennsylvania corporation ("*Entercom*"), as assigned in part by Entercom to Assignee, Assignor has agreed to assign all of its right, title and interest in, to and under the Marks to Assignee, and Assignee has agreed to accept such assignment.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the terms and conditions of the Purchase Agreement, Assignor hereby sells, assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in, to and under the Marks, whether statutory or at common law, including all registrations and applications therefor, the right to recover for past infringement, and the goodwill associated with such Marks in the operation of the business of radio broadcast stations.

This Assignment is intended to evidence the consummation of the transactions contemplated by the Purchase Agreement and is subject to the terms and conditions set forth in the Purchase Agreement. This Assignment is made without representation or warranty, except as provided in and by the Purchase Agreement. Nothing contained in this Assignment shall be construed to supersede, limit or qualify any provision of the Purchase Agreement. To the extent there is a conflict between the terms and provisions of this Assignment and the terms and provisions of the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern.


