RELEASE OF SECURITY INTERESTS

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement (as amended, the "Security Agreement") entered into on November 27, 2001 between Electric Machinery Company, Inc., a Delaware corporation, ("EMCI"), and Wells Fargo Business Credit, Inc., a Minnesota corporation ("Wells Fargo Business Credit"), EMCI granted a security interest to Wells Fargo Business Credit in certain Patents and Trademarks (as defined in the Security Agreement), in the goodwill of EMCI's business connected with and symbolized by the Trademarks, and in all proceeds, indemnities, warranties and guaranties, including all other forms of collateral identified in the Security Agreement (collectively the "Secured Property"); and

WHEREAS, such Security Agreement was recorded within the records of the United States Patent and Trademark Office at reel 2444, frame 0379; and

WHEREAS, all of the obligations arising in connection with the grant of the security interest have now been satisfied and Wells Fargo Bank, National Association ("Wells Fargo"), successor in interest to Wells Fargo Business Credit desires to formally release its security interest and all right, title and interest of Wells Fargo in and to the Secured Property; and

WHEREAS, pursuant to the Security Agreement, Wells Fargo agreed to execute and deliver to EMCI all instruments as may be necessary or proper to extinguish Wells Fargo's security interests in the Patents and Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wells Fargo does hereby release and forever discharge and reconvey to EMCI all of Wells Fargo's security interest in EMCI's right, title, and interest in, to and under the Secured Property, including Wells Fargo's security interest in the trademark registrations identified on Schedule A, attached hereto, so that it is as if the security interest had never been granted by EMCI; and Wells Fargo does further acknowledge and affirm that all of the rights and remedies of Wells Fargo with respect to the security interest and mortgage concerning the Secured Property have been and are hereby extinguished; and Wells Fargo further agrees to perform all additional acts necessary (including executing additional documents) to confirm that Wells Fargo has no interests of any type in, to, or under the Security Property.

IN WITNESS WHEREOF, Wells Fargo has caused this RELEASE OF SECURITY INTERESTS to be executed and delivered as of the 25th day of September, 2008.
