IN NO EVENT SHALL ASSIGNOR OR ANY OF ITS PARENT COMPANIES, SUBSIDIARIES OR AFFILIATES BE LIABLE FOR ANY CLAIM, DAMAGES OR OTHER LIABILITY, WHETHER IN ANY ACTION OF CONTRACT, TORT OR OTHERWISE, ARISING FROM, OUT OF, OR IN CONNECTION WITH THE TRADEMARK OR THIS ASSIGNMENT.

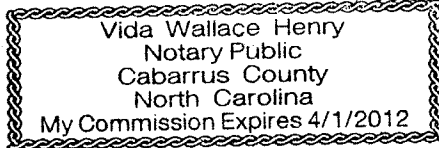

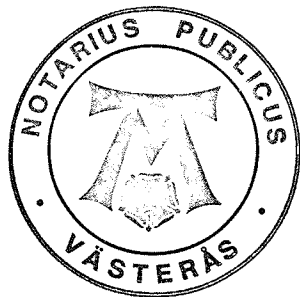
