## ASSIGNMENT AGREEMENT

WHEREAS, **Air Products and Chemicals, Inc.** (hereinafter "AIR PRODUCTS"), a Delaware corporation having its principal place of business at 7201 Hamilton Boulevard, Allentown, Pennsylvania 18195-1501, is the owner of certain US trademark registrations for the trademarks "HEALTHY STEPS", associated with *providing health information services to patients via home visits by trained therapists based on referrals from physicians, namely, health information regarding the management of chronic obstructive pulmonary disease (COPD) and respiratory therapy for pulmonary hypertension, congestive heart failure, lung cancer, and cystic fibrosis; health care services, namely, providing comprehensive respiratory services related to treatment of obstructive sleep apnea (OSA) based on referrals from physicians;* and "AMERICAN PHARMACY CARE", associated with *retail pharmacy services relating to respiratory nebulizer medications; and home health care services relating to respiratory nebulizer medications;* and

WHEREAS, **American Homecare Supply LLC** (hereinafter "AHS"), a Delaware Limited Liability Corporation having its principal place of business at 101 West Elm Street, Conshohocken, PA 19428, desires to acquire the entire right, title and interest in the said "HEALTHY STEPS" and "AMERICAN PHARMACY CARE" trademarks, including such registrations.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged. AIR PRODUCTS does by these presents assign, convey, transfer and delivery to AHS, its successors and assigns, the entire right, title and interest, worldwide, in and to the aforesaid trademarks, including such registrations, and in particular, the following:

AIR PRODUCTS agrees with AHS to assign, sell, execute and deliver, or cause to be assigned, sold, executed and delivered, and to do or make or cause to be done or made, upon reasonable request by AHS and AIR PRODUCTS' expense, any and all instruments, papers, deeds, acts or things, supplemental, confirmatory or otherwise, as may be reasonably required by AHS for the purpose of or in connection with more effectively vesting in AHS or evidencing the vesting in AHS of the aforesaid trademark registrations for the trademarks "HEALTHY STEPS" and "AMERICAN PHARMACY CARE".
