RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS (this "Release") is made as of November 5, 2008 (the "Effective Date") by CANADIAN IMPERIAL BANK OF COMMERCE, acting through its New York agency, as agent for the Creditors (in such capacity, the "Administrative Agent"), in favor of DEI HEADQUARTERS, INC. (the "Pledgor").

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement, dated as of September 22, 2006, between the Pledgor, the other pledgors party thereto and the Administrative Agent (the "Security Agreement"; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement), the Pledgor granted to the Administrative Agent a continuing security interest in all of their right, title and interest in and to the trademarks, including without limitation the trademark registrations and applications and trade name registrations set forth on Schedule I hereto (collectively, the "Trademarks"), together with the goodwill associated therewith;

WHEREAS, the Security Agreement relating to the Trademarks was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on November 10, 2006 at Reel 3426, Frame 0081.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Security Agreement in so far as it relates to the Trademarks, and hereby terminates, cancels, repledges, reassigns and releases any and all security interests it has against the Trademarks together with the goodwill associated therewith, without warranty or recourse.

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Pledgor.

The Administrative Agent shall take all further actions, and provide to the Pledgor and each of their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Pledgor to more fully and effectively effectuate the purposes of this Release.
