TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 6, 2008, is made by Goldman Sachs Credit Partners L.P., as Second Lien Collateral Agent (the "Secured Party") in favor of NOMA, Inc. (the "Grantor").

WHEREAS, the Grantor has granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in the Trademark Collateral (as defined below), pursuant to the Second Lien Pledge and Security Agreement, dated as of February 28, 2005, between the Grantor and the other grantors party thereto, and the Secured Party;

WHEREAS, the security interest granted to the Secured Party in respect of the Trademark Collateral was recorded at the United States Patent and Trademark Office on March 8, 2005 at Reel 3042 and Frame 0682; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Trademark Collateral.

NOW, THEREFORE, for valuable consideration, the Secured Party hereby terminates and releases all of its liens on and security interests in all of the Grantor's right, title and interest in, to and under the following (collectively referred to as the "Trademark Collateral"):


1. the trademark and service mark registrations identified on Schedule A attached hereto, and all extensions or renewals thereof;

4. all proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit.
