## INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "**Agreement**"), is dated as of October 16, 2008, between Personnel Decisions International Corporation, a Delaware corporation (the "**Debtor**"), JPMorgan Chase Bank, N.A. (the "**Secured Party**") and certain Subsidiaries of the Borrower shown on the signature page below (the "**Subsidiaries**", together with the Debtor, collectively, the "**Obligated Party**").

### PRELIMINARY STATEMENT

The Debtor and the Secured Party are entering into a Credit Agreement dated as of even date herewith (as it may be amended, restated, supplemented or modified from time to time, the "**Credit Agreement**"). The Obligated Party is entering into this Agreement in order to, among other things, induce the Secured Party to enter into and extend credit to the Obligated Party under the Credit Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as Collateral security for the prompt and complete performance of its Obligations and payment when due of its Indebtedness under the Credit Agreement and all other agreements now existing or hereafter arising between the Obligated Party and the Secured Party, the Obligated Party and the Secured Party agree as follows:

Section 1.     **Definitions; Interpretation.**

(a)     **Terms Defined in Credit Agreement.** All capitalized terms used in this Agreement and not otherwise defined herein shall have the meanings assigned to them in the Credit Agreement.

(b)     **Certain Defined Terms.** As used in this Agreement, the following terms shall have the following meanings:

**"Collateral"** has the meaning set forth in **Section 2.**

**"PTO"** means the United States Patent and Trademark Office.

**"UCC"** means the Uniform Commercial Code as in effect in the State of Texas, as the same has been or may be amended or revised from time to time, or if so required with respect to any particular collateral by mandatory provisions of applicable law, as in effect in the jurisdiction in which such collateral is located.

(c)     **Terms Defined in UCC.** Where applicable in the context of this Agreement and except as otherwise defined herein, terms used in this Agreement shall have the meanings assigned to them in the UCC.

(d)     **Construction.** In this Agreement, the following rules of construction and interpretation shall be applicable: (i) no reference to "proceeds" in this Agreement authorizes any sale, transfer, or other disposition of any Collateral by the Obligated Party; (ii) "includes" and "including" are not limiting; (iii) "or" is not exclusive; and (iv) "all" includes "any", and "any" includes "all". To the extent not inconsistent with the foregoing, the rules of construction and

interpretation applicable to the Credit Agreement shall also be applicable to this Agreement and are incorporated herein by this reference.

Section 2. **Security Interest.**

(a) **Grant of Security Interest.** As security for the payment of the Indebtedness and performance of the Obligations, the Obligated Party hereby assigns, transfers and conveys to the Secured Party, and grants to the Secured Party a security interest in and mortgage to, all of the Obligated Party's right, title and interest in, to and under the following property, in each case whether now or hereafter existing or arising or in which the Obligated Party now has or hereafter owns, acquires or develops an interest and wherever located (collectively, the "**Collateral**"):

- (i) all patents and patent applications, domestic or foreign, all licenses relating to any of the foregoing and all income and royalties with respect to any licenses (including such patents and patent applications as described in **Schedule "A"**), all rights to sue for past, present or future infringement thereof, all rights arising therefrom and pertaining thereto and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof;
- (ii) all United States registered copyrights, copyright applications and copyright registrations, including Obligated Party's United States registered copyrights and copyright registrations and United States applications for copyright registrations listed in **Schedule "B"** to this Agreement and all of Obligated Party's copyrights that are not registered in the United States Copyright Office, including, without limitation, derivative works (collectively, the "**Copyrights**"), any and all license agreements with respect to the Copyrights and any and all royalties, payments and other amounts payable to Obligated Party in connection with the Copyrights, together with all renewals and extensions of the Copyrights, all rights to sue for past, present or future infringement of the Copyrights, and all manuscripts, documents, writings, tapes, disks, storage media, computer programs, computer databases, computer flow diagrams, source codes, object codes and all tangible property embodying or incorporating the Copyrights, and all other rights of every kind whatsoever accruing thereunder or pertaining thereto;
- (iii) all state (including common law), federal and foreign trademarks, service marks and trade names, and applications for registration of such trademarks, service marks and trade names (but excluding any application to register any trademark, service mark or other mark prior to the filing under applicable law of a verified statement of use (or the equivalent) for such trademark, service mark or other mark to the extent the creation of a security interest therein or the grant of a mortgage thereon would void or invalidate such trademark, service mark or other mark), all licenses relating to any of the foregoing and all income and royalties with respect to any licenses (including such trademarks, names and applications as described in **Schedule "C"**), whether registered or unregistered and wherever registered, all rights to sue for past, present or future infringement or unconsented use thereof, all rights arising therefrom and pertaining thereto and all reissues, renewals and thereof;

- (iv) the entire goodwill of or associated with the business now or hereafter conducted by Obligated Party connected with and symbolized by any of the properties and assets listed in Subsection (a)(iii) above;
- (v) all tangible property, general intangibles and all intangible intellectual or other similar property of the Obligated Party of any kind or nature, embodying or incorporating, associated with or arising out of any of the aforementioned properties and assets and not otherwise described above; and
- (vi) all cash and non-cash proceeds of any and all of the foregoing Collateral (including license royalties, rights to payment, accounts and proceeds of infringement suits) and, to the extent not otherwise included, all payments under insurance (whether or not the Secured Party is the loss payee thereof) or any indemnity, warranty or guaranty payable by reason of loss or damage to or otherwise with respect to the foregoing Collateral.

(b) **Continuing Security Interest.** The Obligated Party agrees that this Agreement shall create a continuing security interest in the Collateral which shall remain in effect until terminated in accordance with **Section 11.**

Section 3. **Supplement to Credit Agreement.** This Agreement has been entered into in conjunction with the security interests granted to the Secured Party under the Credit Agreement and other Security Documents referred to therein, including but not limited to the Security Agreement. The rights and remedies of the Secured Party with respect to the security interests granted herein are without prejudice to, and are cumulative, concurrent and in addition to those set forth in the Credit Agreement or any other Security Documents referred to therein, all terms and provisions of which are incorporated herein by reference.

Section 4. **Representations and Warranties.** The Obligated Party represents and warrants to the Secured Party that a true and correct list of all of the existing Collateral consisting of: (a) U.S. patents and patent applications or registrations owned by the Obligated Party, in whole or in part, is set forth in **Schedule "A"**; (b) U.S. registered copyrights, copyright registrations and applications owned by the Obligated Party, in whole or in part, is set forth in **Schedule "B"**; (c) U.S. trademarks, trademark registrations or applications owned by the Obligated Party, in whole or in part, is set forth in **Schedule "C"**. The Obligated Party further represents and warrants that all representations and warranties contained in Article Five of the Credit Agreement and in each of the other Loan Documents are true and correct as of the date hereof.

Section 5. **Further Acts.** On a continuing basis, the Obligated Party shall make, execute, acknowledge, deliver, file and record in the proper filing and recording places, all such instruments and documents, and take all such action as may be necessary or advisable or may be requested by the Secured Party to carry out the intent and purposes of this Agreement, or for assuring, confirming or protecting the grant or perfection of the security interest granted or purported to be granted hereby, to ensure the Obligated Party's compliance with this Agreement or to enable the Secured Party to exercise and enforce its rights and remedies hereunder with respect to the Collateral, including any documents for filing with the PTO or any applicable state office. The Secured Party may record this Agreement, an abstract thereof, or any other document describing the Secured Party's interest in the Collateral with the PTO, at the expense of the Obligated Party. In addition, the Obligated Party authorizes the Secured Party to file financing statements describing the Collateral in any UCC filing office deemed appropriate by the

Secured Party. If the Obligated Party shall at any time hold or acquire a commercial tort claim arising with respect to the Collateral, the Obligated Party shall immediately notify the Secured Party in a writing signed by the Obligated Party of the brief details thereof and grant to the Secured Party in such writing a security interest therein and in the proceeds thereof, all upon the terms of this Agreement, with such writing to be in form and substance satisfactory to the Secured Party.

Section 6. **Authorization to Supplement.** If the Obligated Party shall obtain rights to (a) any new copyright, copyright registrations or applications, trademark, trademark registrations or applications, patents or patent applications or registrations, or (b) to any reissue, division, renewal, extension or continuation of any copyright, copyright registrations or applications, trademark, trademark registrations or applications, patents or patent applications or registrations, the provisions of this Agreement shall automatically apply thereto. The Obligated Party shall give prompt notice in writing to the Secured Party with respect to any such new patent, copyright or trademark rights. Without limiting the Obligated Party's obligations under this **Section 6**, the Obligated Party authorizes the Secured Party unilaterally to modify this Agreement by amending **Schedule "A"**, **Schedule "B"** or **Schedule "C"**, as the case may be, to include any such new patent, copyright or trademark rights. Notwithstanding the foregoing, no failure to so modify this Agreement or amend **Schedule "A"**, **Schedule "B"** or **Schedule "C"** shall in any way affect, invalidate or detract from the Secured Party's continuing security interest in all Collateral, whether or not listed on **Schedule "A"**, **Schedule "B"** or **Schedule "C"**.

Section 7. **Binding Effect.** This Agreement shall be binding upon, inure to the benefit of and be enforceable by the Obligated Party, the Secured Party and their respective successors and assigns. The Obligated Party may not assign, transfer, hypothecate or otherwise convey its rights, benefits, obligations or duties hereunder except as specifically permitted by the Credit Agreement.

Section 8. **Governing Law.** This Agreement shall be governed by, and construed in accordance with, the law of the State of Texas except as required by mandatory provisions of law or to the extent the perfection or priority of the security interests hereunder, or the remedies hereunder, in respect of any Collateral are governed by the law of a jurisdiction other than Texas.

Section 9. **Entire Agreement; Amendment.** This Agreement and the Credit Agreement, together with the Schedules and Exhibits hereto and thereto, contains the entire agreement of the parties with respect to the subject matter hereof and supersedes all prior drafts and communications relating to such subject matter. Neither this Agreement nor any provision hereof may be modified, amended or waived except by the written agreement of the parties, as provided in the Credit Agreement. Notwithstanding the foregoing, the Secured Party unilaterally may re-execute this Agreement or modify, amend or supplement the Schedule hereto as provided in **Section 6** hereof. To the extent that any provision of this Agreement conflicts with any provision of the Credit Agreement, the provision giving the Secured Party greater rights or remedies shall govern, it being understood that the purpose of this Agreement is to add to, and not detract from, the rights granted to the Secured Party under the Credit Agreement.

Section 10. **Counterparts.** This Agreement may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute but one and the same agreement. Delivery of an executed counterpart of this Agreement by facsimile shall be equally as effective as delivery of a manually executed counterpart. Any party hereto delivering a counterpart of this Agreement by facsimile shall also deliver a manually executed counterpart, but the failure to so deliver a manually executed counterpart shall not affect the validity, enforceability, or binding effect hereof.

Section 11. **Termination**. Upon payment and performance in full of all Obligations, the security interests created by this Agreement shall terminate, and the Secured Party (at the Obligated Party's expense) shall promptly execute and deliver to the Obligated Party such documents and instruments reasonably requested by the Obligated Party as shall be necessary to evidence termination of all such security interests given by the Obligated Party to the Secured Party hereunder, including cancellation of this Agreement by written notice from the Secured Party to the PTO.

Section 12. **No Inconsistent Requirements**. The Obligated Party acknowledges that this Agreement and the other documents, agreements and instruments entered into or executed in connection herewith may contain covenants and other terms and provisions variously stated regarding the same or similar matters, and the Obligated Party agrees that all such covenants, terms and provisions are cumulative and all shall be performed and satisfied in accordance with their respective terms.

Section 13. **Severability**. If one or more provisions contained in this Agreement shall be invalid, illegal or unenforceable in any respect in any jurisdiction or with respect to any party, such invalidity, illegality or unenforceability in such jurisdiction or with respect to such party shall, to the fullest extent permitted by applicable law, not invalidate or render illegal or unenforceable any such provision in any other jurisdiction or with respect to any other party, or any other provisions of this Agreement.

Section 14. **Notices**. All notices and other communications hereunder shall be in writing and shall be mailed, sent or delivered in accordance with the Credit Agreement.




