## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of November 25, 2008, (as it may be amended, restated, supplemented, or otherwise modified from time to time, this "Agreement") is made by each of the entities identified as grantors on the signature pages hereof (each a "Grantor" and, collectively, the "Grantors"), in favor of Deutsche Bank AG, New York Branch ("Deutsche Bank"), as Collateral Agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the "Collateral Agent").

### WITNESSETH:

WHEREAS, pursuant to the Second Amended and Restated Credit and Guaranty Agreement, dated as of May 25, 2006, as amended pursuant to the First Forbearance Agreement and Second Amendment to Second Amended and Restated Credit and Guaranty Agreement, dated as of November 12, 2008 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Simmons Bedding Company (formerly known as Simmons Company), a Delaware corporation ("Company"), THL-SC Bedding Company, a Delaware corporation ("Holdings"), certain Subsidiaries of Company, as Credit Support Parties, Goldman Sachs Credit Partners L.P., as sole bookrunner, Lead Arranger and Syndication Agent, certain financial institutions listed herein, as Lenders, and Deutsche Bank, as Administrative Agent and Collateral Agent, Lenders have severally agreed to make extensions of credit to the Company upon the terms and subject to the conditions set forth therein;

WHEREAS, each Grantor (other than the Company) has agreed, pursuant to a Pledge and Security Agreement, dated as of December 19, 2003, in favor of the Collateral Agent (the "Pledge and Security Agreement"), to secure such Grantor's obligations under the Credit Agreement and the Hedge Agreement (as defined in the Credit Agreement); and

WHEREAS, all of the Grantors are party to the Pledge and Security Agreement pursuant to which the Grantors are required to execute and deliver this Agreement;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each Grantor hereby agrees with the Collateral Agent, for the benefit of the Secured Parties, as follows:

Section 1. Defined Terms. Capitalized terms used herein without definition are used as defined in the Pledge and Security Agreement.

Section 2. Grant of Security Interest in Trademark Collateral. Each Grantor, hereby grants to the Collateral Agent a security interest in, and lien on all of such Grantor's right, title and interest to and under the following, in each case whether now owned or existing or hereafter acquired or arising and wherever located (collectively, the "Trademark Collateral"):

(a) all United States; and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certification marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, all registrations and applications for any of the foregoing including, but not limited to: (i) the registrations and applications referred to in Schedule A attached hereto, and (ii) all extensions or renewals of any of the foregoing;

(b) all of the goodwill of the business connected with the use of and symbolized by the foregoing;

(c) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill; and

(d) all Proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit.

Notwithstanding anything herein to the contrary, in no event shall the security interest and lien granted under this Section 2 attach to (nor shall the Trademark Collateral include) any property rights or licenses, if and for so long as the grant of such security interest shall constitute or result in the abandonment, invalidation, or unenforceability of any right, title or interest of any Grantor therein, or in breach or termination pursuant to the terms of, or a default under, any property rights or licenses pertaining to or arising from the foregoing Trademark Collateral (including, without limitation, any "intent-to-use" application for registration of a Trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a "Statement of Use" pursuant to Section 1(d) of the Lanham Act or an "Amendment to Allege Use" pursuant to Section 1(c) of the Lanham Act with respect thereto, solely to the extent, if any, that, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law), provided, however, that such security interest shall attach immediately at such time as the condition causing such abandonment, invalidation or unenforceability shall no longer be effective and to the extent severable, shall attach immediately to any portion of such license or property rights that does not result in any of the foregoing consequences.

Section 3. Authorization to Supplement. Each Grantor hereby authorizes the Collateral Agent unilaterally to modify this Trademark Security Agreement by amending Schedule A to include any future Trademark Collateral of such Grantor. Notwithstanding the foregoing, no failure to so modify this Trademark Security Agreement or amend Schedule A shall in any way affect, invalidate or detract from the Collateral Agent's or Secured Parties' continuing security interest in all Trademark Collateral, whether or not listed on Schedule A.

Section 4. Pledge and Security Agreement. The security interest granted by this Agreement to the Collateral Agent for the Secured Parties is granted in conjunction with and pursuant to the Pledge and Security Agreement, and each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Pledge and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Pledge and Security Agreement, the provisions of the Pledge and Security Agreement shall control.

Section 5. Counterparts. This Agreement may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed to be an original, but all such counterparts together shall constitute but one and the same instrument. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart so that all signature pages are physically attached to the same document.

Section 6. Governing Law. THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO ITS CONFLICTS OF LAW

PROVISIONS (OTHER THAN SECTION 5-1401 AND SECTION 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAWS).
