**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

TERMINATION AND RELEASE dated as of November 26, 2008, from Lehman Commercial Paper, Inc., a New York corporation, as Administrative Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to Heckethorn Manufacturing Co., LLC, a Delaware limited liability company (as successor-in-interest to Heckethorn Manufacturing Co., Inc.).

WITNESSETH:

WHEREAS, pursuant to the Grant of Security Interest in Trademark Rights, dated as of July 21, 2006, made by the Grantors (as defined therein) in favor of the Agent (the "Security Agreement"), in connection with the Second Lien Guarantee and Collateral Agreement, dated as of July 21, 2006, a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, dated as of July 21, 2006, including the trademarks set forth on Schedule A hereto (the "Trademark Collateral");

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on August 8, 2006 at Reel 3364, Frame 0379; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Release of Security Interest: The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

2. Further Assurances: The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
