## Trademark Security Agreement

This **Trademark Security Agreement**, is made this 25th of November, 2008 (this "Agreement"), among Pledgors listed on the signature pages hereof (collectively, jointly and severally, "Pledgors" and each individually "Pledgor") and UBS AG, Stamford Branch in its capacity as administrative agent pursuant to the Credit Agreement (as defined below) (in such capacity, the "Administrative Agent").

### WITNESSETH:

WHEREAS, Pledgors are party to that certain Security Agreement of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Administrative Agent entered into in connection with that certain Senior Secured, Super-Priority Debtor-In-Possession Revolving Credit Agreement of even date herewith among D 56, INC., a Minnesota corporation, Lenox Retail, Inc., a Minnesota corporation, and Lenox, Incorporated, a New Jersey corporation, as Borrowers, Lenox Group Inc., a Delaware corporation, and the Subsidiary Guarantors (as defined in the Credit Agreement), as Guarantors, the Administrative Agent, the other agents party thereto and the other financial institutions party thereto (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and pursuant to which the Pledgors are required to execute and deliver this Agreement;

Now, THEREFORE, in consideration of the premises and to induce the Administrative Agent, for the benefit of the Secured Parties, to enter into the Security Agreement, the Pledgors hereby agree with the Administrative Agent as follows:

Section 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

Section 2. Grant of Security Interest in Trademark Collateral. Each Pledgor hereby pledges and grants to the Administrative Agent, for the benefit of the Secured Parties, a lien on and security interest in and to all of its right title and interest in, to and under the following Pledged Collateral of such Pledgor:

- (a) registered Trademarks, and applications therefore, of such Pledgor listed on Schedule I attached hereto;
- (b) all reissues, continuations or extensions of the foregoing;
- (c) all business goodwill associated with such Trademarks; and
- (d) all Proceeds of any and all of the foregoing.

Section 3. Security Agreement. The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the Security Agreement and Pledgors hereby acknowledge and affirm that the



rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

Section 4. Termination. Upon the full performance of the Obligations, the Administrative Agent shall execute, acknowledge, and deliver to the Pledgors an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Trademarks under this Agreement.


