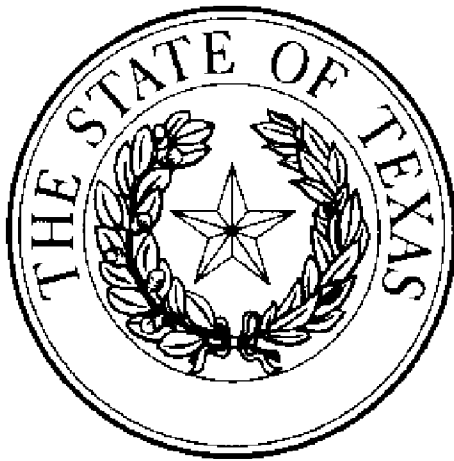

**ARTICLES OF CONVERSION
OF
INTERNATIONAL DEVELOPMENT CORPORATION**

Corporations Section

Pursuant to the provisions of Articles 5.17 through 5.20 of the Texas Business Corporation Act and Section 2.15 of the Texas Revised Limited Partnership Act, International Development Corporation, a Texas corporation (the "Converting Entity"), hereby adopts and certifies the following Articles of Conversion for the purpose of effecting a conversion of the Converting Entity into International Development, Ltd., a Texas limited partnership (the "Converted Entity") in accordance with the provisions of the Texas Business Corporation Act and the Texas Revised Limited Partnership Act:

1. The name, registered address, form of organization and date of incorporation of the Converting Entity and the state under the laws of which it is organized is:

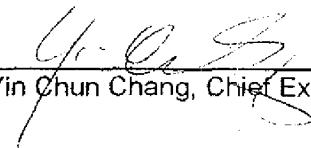
