NUNC PRO TUNC TRADEMARK/COPYRIGHT ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, MRA Systems, Inc., incorporated in the State of Delaware, U.S.A., having a place of business at 1426 Pearl Street, Boulder, Colorado 80302 (hereinafter "MRA Systems" or "ASSIGNOR") and Avnet, Inc., incorporated and registered in the State of New York, U.S.A., having a place of business at 2211 South 47th Street, Phoenix, AZ 85034 (hereinafter "AVNET" or "ASSIGNEE"), did enter into a Stock and Asset Purchase Agreement dated November 6, 2006, wherein ASSIGNOR agreed to and did sell certain assets including the trademarks and copyright listed on the attached Schedule A (hereinafter, the "INTELLECTUAL PROPERTY") and the good will of the business in connection with which the INTELLECTUAL PROPERTY is used;

WHEREAS, MRA Systems did transfer assets including the subject INTELLECTUAL PROPERTY to Avnet effective November 6, 2006, by unrecorded agreement between the parties; and

NOW, THEREFORE, IT IS HEREBY AGREED:


1. In consideration of the sum of One Dollar (\$1.00) and other good valuable considerations to it in hand paid, the receipt of which is hereby acknowledged, ASSIGNOR, does hereby sell, assign and transfer unto ASSIGNEE the entire right, title and interest in and to the INTELLECTUAL PROPERTY (whether registered or held in common law), together with the good will of the business in connection with which the INTELLECTUAL PROPERTY is used, any and all causes of action including all rights of recovery for past infringements of the INTELLECTUAL PROPERTY, and any registrations and/or applications for registration of the INTELLECTUAL PROPERTY, including but not limited to the registrations listed in Schedule 1 attached hereto and incorporated by reference herein.

2. ASSIGNOR covenants that it or its representatives will, upon the request and at the expense of ASSIGNEE, do all other lawful acts and execute all documents necessary to enable ASSIGNEE to obtain, maintain, and enforce full benefits from the

rights and interests herein assigned. ASSIGNOR shall do all acts that may be reasonably required by ASSIGNEE in order to effectuate the assignment of the Trademarks.
