RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of December 19, 2008 (“Effective Date”) by and between Credit Suisse, Cayman Islands Branch (“Administrative Agent”) and F+W Media, Inc., formerly F&W Publications, Inc., a Delaware corporation, with its principal office at 4700 E. Galbraith Road, Cincinnati, Ohio 45236 (“Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Grant of Security Interest in Trademark Rights by and between Grantor and Administrative Agent dated September 1, 2005 (the “Trademark Security Agreement”), Grantor pledged and granted to Administrative Agent a continuing security interest in and to all of Grantor’s right, title and interest in and to the United States trademark registrations and applications set forth on Schedule A attached hereto, together with the goodwill of the business connected therewith (collectively, the “Trademarks”); and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on October 10, 2005, at Reel 3172, Frame 0443 et seq.;

NOW, THEREFORE, Administrative Agent hereby grants, assigns and conveys to Grantor all of its rights, title and interest in the Trademarks, and terminates, cancels and releases any and all security interests or liens it has against the Trademarks.

Administrative Agent shall, at Grantor’s expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
