This Assignment constitutes the entire and final agreement of the parties with respect to the subject matter hereof and supersedes the assignment effective July 31, 2008, and any and all prior assignments, agreements, representations, promises and undertakings of any kind, whether oral or written.

IN WITNESS WHEREOF, the parties hereto have executed this Assignment to be executed as of the Effective Date.




