CONFIRMATORY ASSIGNMENT OF U.S. TRADEMARK

WHEREAS, T-N-T International, Inc., a Texas corporation, having its principal place of business at 580 Catalina, Waco, Texas 76712 (hereinafter "ASSIGNOR"), was the owner of the entire right, title and interest, including goodwill, in and to the trademark and U.S. Registration No. 1,922,195 for FABULOUS FIDDLESTIX, and the goodwill symbolized by the mark (hereinafter "MARK"); and

WHEREAS, Poof-Slinky, Inc., a Michigan corporation, having its principal place of business at 45400 Helm Street, P.O. Box 701394, Plymouth Michigan 48170-0964 (hereinafter "ASSIGNEE") acquired ASSIGNOR'S entire right, title and interest in and to the MARK, and the goodwill symbolized by the MARK by an Asset Purchase Agreement dated May 1, 2005;

WHEREAS, ASSIGNOR AND ASSIGNEE wish to memorialize the trademark registration acquisition in an instrument suitable for recording;

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, including the covenants and undertakings set forth in the Asset Purchase Agreement dated May 1, 2005, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR does hereby confirm the assignment and transfer unto ASSIGNEE of ASSIGNOR'S entire right, title and interest in and to said MARK, together with the entire goodwill of the business symbolized by the MARK, and the right to prosecute and recover for any past infringements thereof, the same to be held and enjoyed by ASSIGNEE, its successors and assigns, as fully and entirely as the same would have been held by ASSIGNOR had an Assignment not been made.

IN WITNESS WHEREOF, ASSIGNOR has caused this CONFIRMATORY ASSIGNMENT to be executed by its duly authorized officer effective as of the 1st day of May, 2005.
