RELEASE OF TRADEMARK SECURITY


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Debtor and Secured Party hereby agree as follows:

As of the Payoff Date, all of Secured Party's security interests, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created pursuant to the Security Agreement (collectively, the "Security Interests") shall be automatically terminated, released and discharged, and the Secured Party hereby authorizes Debtor to file any such documents, including filings with the U.S. Patent and Trademark Office against the trademarks listed in Schedule A hereto, as shall be necessary to effect the termination, release and discharge of all of the Security Interests. In addition, promptly upon the request of Debtor, Secured Party will do any and all other acts and things and execute and deliver any and all other documents or instruments that Debtor may reasonably require.

This Release may be executed in any number of counterparts, and shall be governed and construed in accordance with the laws of the State of Illinois, without regard to the principles thereof relating to conflict of laws.
