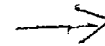

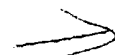

### Trademark Security Agreement

**Trademark Security Agreement**, dated as of April 30, 2007, by HABAND COMPANY, INC., a Delaware corporation ("Haband"), JOHNNY APPLESEED'S, INC., a Massachusetts corporation ("JAI"), NORM THOMPSON OUTFITTERS, INC., an Oregon corporation ("NTO") and DRAPER'S & DAMON'S, INC., a California corporation ("DDI" and, together with Haband, JAI and NTO the "Pledgors," and each, a "Pledgor"), in favor of UBS AG, STAMFORD BRANCH, in its capacity as Administrative Agent pursuant to the Credit Agreement (in such capacity, the "Administrative Agent").

#### WITNESSETH:

WHEREAS, the Pledgors are party to a Security Agreement of even date herewith (the "Security Agreement") in favor of the Administrative Agent pursuant to which the Pledgors are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Administrative Agent, for the benefit of the Secured Parties, to enter into the Credit Agreement, the Pledgors hereby agree with the Administrative Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. 
