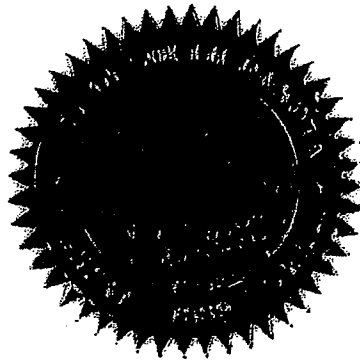

1. The names of the merger entities are Orion Food Systems, Inc., a South Dakota corporation, and Orion Food Systems of South Dakota, LLC, a South Dakota limited liability company.
2. Articles of Organization of Orion Food Systems of South Dakota, LLC were filed with the South Dakota Secretary of State on February 5, 2002. Articles of Incorporation of Orion Food Systems, Inc. were filed with the South Dakota Secretary of State on October 20, 1993.
3. Annexed hereto and made a part hereof is the Plan of Merger for merging Orion Food Systems, Inc. with and into Orion Food Systems of South Dakota, LLC, which has been approved and signed by each of the Orion Food Systems, Inc. and Orion Food Systems of South Dakota, LLC.
4. Orion Food Systems of South Dakota, LLC, whose address is 2930 W. Maple Street, Sioux Falls, South Dakota 57501, is the surviving limited liability company.
5. There are outstanding 1,000,000 shares of common stock of Orion Food Systems, Inc., and the holder of such shares is required to vote on the Plan of Merger. The Plan of Merger has been approved by the required vote of such stockholder of Orion Food Systems, Inc. in accordance with the South Dakota Business Corporation Act.
