**RELEASE OF NOTICE OF GRANT OF  
SECURITY INTEREST IN TRADEMARKS**

Release of Notice of Grant of Security Interest in Trademarks (this "Release"), dated as of the 13th day of February, 2009, made by **Bank of America, N.A., as Collateral Agent**, (hereinafter the "Administrative Agent"), in favor of **Take-Two Interactive Software, Inc. (successor-in-interest to Talonsoft, Inc.)** (hereinafter the "Pledgor").

R E C I T A L S

A. The Pledgor and Administrative Agent entered into a certain Notice of Grant of Security Interest in Trademarks, dated as of **December 7, 1999** and recorded with the United States Patent & Trademark Office on **August 22, 2002** at **Reel 2570, Frame 0109** (the "Agreement"); capitalized terms used herein and not defined shall have the meanings set forth in the Agreement, pursuant to which the Pledgor granted to Administrative Agent a lien on and security interest in certain Trademark Collateral owned by the Pledgor.

B. In accordance with the terms of the Agreement, the Pledgor has satisfied all of its outstanding obligations under the Agreement and, in connection therewith, the Pledgor has requested Administrative Agent to release, and Administrative Agent has agreed to release, its lien on all trademark collateral pledged pursuant to the Agreement.


A G R E E M E N T

Administrative Agent hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by the Pledgor pursuant to the Agreement in all trademark collateral, including without limitation, the trademarks identified on Exhibit A annexed hereto (collectively, the "Released Collateral"), the goodwill associated with and symbolized by the trademarks identified on Exhibit A, and all liens, security interests, charges or other encumbrances in favor of Administrative Agent in the Released Collateral shall hereby terminate and revert to the Pledgor and all right, title and interest of Administrative Agent in the Released Collateral will hereby cease, terminate and become void.
