**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
TRADEMARK RIGHTS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Agreement"), dated as of January 23, 2009, is given by Wells Fargo Business Credit, Inc., a Minnesota corporation, located at 245 South Los Robles Avenue, Suite 600, Pasadena, CA 91101 (the "Lender").

WHEREAS, pursuant to that certain Agreement dated as of January 27, 2000, between Naturade, Inc., a Delaware corporation, located at 2099 S.
