Assignor further conveys, transfers, and assigns to Assignee all rights to sue for and receive all damages occurring from past infringing uses of the Mark.


Assignor warrants that it has good and valid title to the Mark, including the applications and registrations therefor.

Assignor agrees that, upon request by Assignee, Assignor shall execute all papers,


