# U.S. COPYRIGHT, PATENT AND TRADEMARK

## SECURITY AGREEMENT

COPYRIGHT, PATENT and TRADEMARK SECURITY AGREEMENT, dated as of February 6, 2009 (together with all amendments, if any, from time to time hereto, this "Copyright, Patent and Trademark Security Agreement"), between the Grantor identified as such on the signature pages hereof (the "IP Grantor"), and Deutsche Bank AG New York Branch, in its capacity as Collateral Agent (the "Collateral Agent") for the Secured Parties (as defined below).

### WITNESSETH:

WHEREAS, pursuant to that certain ABL Credit Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), dated as February 6, 2009 among INVISTA B.V. ("Holdings"), INVISTA S.à r.l., INVISTA (Canada) Company, the lenders party thereto from time to time (the "Lenders") and Deutsche Bank AG New York Branch, as Administrative Agent, the Lenders have agreed to make Loans and issue Letters of Credit to or for the benefit of, the Borrowers;

WHEREAS, in order to induce the Administrative Agent and Lenders to enter into the Credit Agreement and the other Credit Documents and to induce the Lenders to make the Loans and issue (or participate in) Letters of Credit as provided for in the Credit Agreement, the IP Grantor has agreed to grant a continuing security interest in the IP Collateral to secure the Obligations, pursuant to the Guarantee and Collateral Agreement, dated as of February 6, 2009 among INVISTA B.V., INVISTA S.à r.l., INVISTA (Canada) Company, the other Subsidiaries of Holdings from time to time party thereto and the Collateral Agent (such agreement, as amended, restated, supplemented or otherwise modified, the "Collateral Agreement"); and

WHEREAS, pursuant to the Collateral Agreement, the IP Grantor is required to execute and deliver to the Collateral Agent, for itself and the ratable benefit of the Secured Parties, this Copyright, Patent and Trademark Security Agreement.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the IP Grantor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in to the Credit Agreement or the Collateral Agreement.
2. Grant Of Security Interest In Copyright, Patent and Trademark Collateral. The IP Grantor hereby grants to the Collateral Agent, on behalf of itself and the Secured Parties, a continuing first priority security interest in all of the IP Grantor's right, title and interest in, and under the following, whether presently existing or hereafter created or acquired (collectively, the "Copyright, Patent and Trademark Collateral"):

- (a) all Copyrights set forth on Schedule I hereto;

(b) all Patents set forth on Schedule II hereto;

(c) all Trademarks set forth on Schedule III hereto;

(d) all renewals of the foregoing;

(e) all goodwill of the business connected with the use of, and symbolized by, each Copyright, Patent and Trademark; and

(f) all products and proceeds of the foregoing, including, without limitation, any claim by the IP Grantor against third parties for past, present or future (i) infringement or dilution of any Copyright, Patent or Trademark or (ii) injury to the goodwill associated with any Copyright, Patent or Trademark.

3. Security Agreement. The security interests granted pursuant to this Copyright, Patent and Trademark Security Agreement are (x) granted in conjunction with the security interests granted to the Collateral Agent, on behalf of itself and the Secured Parties, pursuant to the Collateral Agreement and (y) made to secure the satisfactory performance and payment of all the Obligations, as such term is defined in the Collateral Agreement, of the IP Grantor. The IP Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Copyright, Patent and Trademark Collateral made and granted hereby are more fully set forth in the Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event there is any conflict between this Copyright, Patent and Trademark Security Agreement and the provisions of the Collateral Agreement, the provisions of the Collateral Agreement shall prevail.

4. Counterparts. This Copyright, Patent and Trademark Security Agreement may be executed in any number of separate counterparts, each of which shall collectively and separately constitute one agreement.






