NOTICE OF CHANGE OF COLLATERAL AGENT –
TRADEMARK SECURITY AGREEMENT

Dated: March 30, 2009

WHEREAS, GAYMAR INDUSTRIES, INC., a New York corporation (“Gaymar”), has entered into that certain Security Agreement dated as of February 14, 2003 (as amended, restated, reaffirmed, supplemented or otherwise modified from time to time, the “Security Agreement”) among Gaymar, the other “Debtors” from time to time party thereto, and ANTARES CAPITAL CORPORATION (“Antares”), as Collateral Agent (as defined in the Security Agreement) for the benefit of certain secured parties (the “Secured Parties”), to secure certain of obligations and liabilities of Gaymar to such Secured Parties;

WHEREAS, pursuant to the Security Agreement, Gaymar granted a first priority security interest in substantially all of Gaymar’s assets, whether then existing or thereafter created or acquired to Antares, as Collateral Agent, for the benefit of the Secured Parties, on the terms and conditions more fully set forth in the Security Agreement;

WHEREAS, Gaymar and Antares, as Collateral Agent, entered into that certain Trademark Security Agreement, dated as of February 14, 2003 (the “Trademark Security Agreement”), which Trademark Security Agreement was recorded on February 25, 2003 in the United States Patent and Trademark Office, Trademark Division, at Reel 2682, Frame 0039; and

WHEREAS, pursuant to the Trademark Security Agreement, Gaymar granted to Antares, as Collateral Agent, a continuing security interest in all of Gaymar’s right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the “Trademark Collateral”), in each case, whether then existing or thereafter created or acquired:

- (1) each Trademark (as defined in the Security Agreement), Trademark registration and Trademark application, including, without limitation, the Trademarks, Trademark registrations (together with any reissues, continuations or extensions thereof) and Trademark applications referred to in **Schedule 1** annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, Trademark registration and Trademark application;
- (2) each Trademark license and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark license; and

(3) all products and proceeds of the foregoing, including, without limitation, any claim by Gaymar against third parties for past, present or future (a) infringement or dilution of any Trademark or Trademark registration including, without limitation, the Trademarks and Trademark registrations referred to in **Schedule 1** annexed hereto, the Trademark registrations issued with respect to the Trademark applications referred in **Schedule 1** and the Trademarks licensed under any Trademark license, or (b) injury to the goodwill associated with any Trademark, Trademark registration or Trademark licensed under any Trademark license.

WHEREAS, Antares has resigned as Collateral Agent under the Security Agreement and the Trademark Security Agreement and GENERAL ELECTRIC CAPITAL CORPORATION (“GE Capital”) has replaced Antares as Collateral Agent thereunder for the benefit of the Secured Parties.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each party, the parties hereto hereby agree and confirm that:

1. Antares has ceased to be the Collateral Agent for the benefit of the Secured Parties under the Security Agreement and the Trademark Security Agreement;
2. GE Capital is now the Collateral Agent for the benefit of the Secured Parties under the Security Agreement and the Trademark Security Agreement;
3. Antares, as Collateral Agent’s first priority security interest in the Trademark Collateral and all of its interests, rights and obligations in, to and/or under the Trademark Security Agreement are hereby assigned and transferred to GE Capital as Collateral Agent for the benefit of the Secured Parties; and
4. the execution and delivery of this Assignment shall not in any way affect or modify the liability of Gaymar under the Security Agreement or the Trademark Security Agreement hereby assigned, it being understood and agreed that notwithstanding this Notice of Change of Collateral Agent – Trademark Security Agreement (this “Assignment”), all of the obligations of Gaymar under the Security Agreement and Trademark Security Agreement shall be and remain enforceable by GE Capital, as Collateral Agent, or by its successors and assigns in such capacity, against Gaymar.


