## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Release") is made as of March 31, 2009 ("Effective Date") by UBS AG, Stamford Branch (the "Collateral Agent") in favor of Norcraft Companies, L.P. (the "Pledgor").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of October 21, 2003, (the "Trademark Security Agreement," each capitalized term used herein without definition shall have the meaning ascribed to such term in the Trademark Security Agreement), the Pledgor pledged and granted to Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under the Pledged Collateral, including, without limitation, its trademarks and trademark applications listed on Schedule I attached hereto which security interest is recorded on April 14, 2005 at Reel 3093 Frame 0213 at the U.S. Patent and Trademark Office;

**WHEREAS**, the Pledgor has paid all of its outstanding indebtedness to the Collateral Agent secured by the Pledged Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all collateral pledge, grant, assignment, lien on and security interests it has in and to the Pledged Collateral.

If and to the extent the Collateral Agent has acquired any right, title or interest in, or to any of the Pledged Collateral, it hereby assigns and transfers such rights, title or interest to the Pledgor without any representations, warranties or recourse of any kind whatsoever.

The Collateral Agent shall take all further actions, and provide to the Pledgor and each of its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgor, at Pledgor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
