**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of February 16, 2007, is made by GOLDMAN SACHS CREDIT PARTNERS L.P. ("GSCP"), as Second Lien Collateral Agent (the "Collateral Agent"), under the Second Lien Credit and Guaranty Agreement, dated as of February 28, 2005 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Gentek Holding, LLC ("Borrower"), Gentek Inc., certain Subsidiaries of Borrower (collectively, the "Grantors"), the lenders party thereto from time to time and the Collateral Agent, with respect to certain Intellectual Property owned by Noma Corporation, Noma O.P., Inc., and Noma, Inc. (collectively, the "Grantors").

WITNESSETH

WHEREAS, pursuant to the Second Lien Pledge and Security Agreement (the "Security Agreement"), by and among the Grantors and the Collateral Agent, dated February 28, 2005 and recorded with the U.S. Patent and Trademark Office on March 8, 2005 at Reel/Frame No. 15747/0386, the Grantors granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of its patents, and proceeds of any and all of the foregoing;

WHEREAS, pursuant to the Security Agreement by and among the Grantors and the Collateral Agent, dated February 28, 2005 and recorded with the U.S. Patent and Trademark Office on March 8, 2005 at Reel/Frame Nos. 3042/0512 and 3042/0682, the Grantors granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all trademarks, all goodwill associated with such trademarks, and proceeds of any and all of the foregoing;

WHEREAS, the Collateral Agent acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Agreement secured by the Security Agreement have been made;


WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in the Intellectual Property Collateral, as defined in the Security Agreement in connection with the termination of the Agreement, and the Security Agreement (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby RELEASES, without recourse, all of its security interest in the Intellectual Property Collateral, listed on Schedule I attached hereto and incorporated herein by reference, and any other collateral described in the Security Agreement.

The Collateral Agent agrees to provide the Grantors with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.
