THIS TRADEMARK RELEASE is made as of June 19, 2009, by CapitalSource Finance LLC ("CapitalSource").

WITNESSETH:

WHEREAS, CapitalSource and Global Compliance Services, Inc., a Delaware corporation ("GCS"), were parties to an Amended and Restated Intellectual Property Security Agreement dated as of January 31, 2006 (the "Assignment"), pursuant to which GCS granted a security interest to CapitalSource in certain trademarks (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by GCS to CapitalSource, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on March 9, 2006, at Reel 3264, Frame 0034; and

1. CapitalSource hereby releases its security interest in all of GCS's right, title and interest in and to the following (collectively the "Trademark Rights"):


