PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST

This Partial Release of Trademark Security Interest ("Partial Release") is given on this 1st day of July 2009 by JPMorgan Chase Bank, National Association, as Administrative Agent (the "Lender") to Farnam Companies, Inc. (the "Debtor"), as follows:

WHEREAS, on April 7, 2006, the Debtor and the Lender entered into a Confirmatory Grant of Security Interest in United States Trademarks ("Security Agreement");
