NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor hereby sells, assigns, and transfers to Assignee its entire right, title, interest in and to the Subject Marks, including in and to all applications, registrations, and common law rights relating thereto, together with the goodwill of the portion
