**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of July 7, 2009, is made by The Bank of New York Mellon formerly known as The Bank of New York ("BONY"), in favor of ATP Plastics, Inc. ("ATP") as follows:

**WITNESSETH**

WHEREAS, pursuant to the First Supplemental Intellectual Property Security Agreement, dated January 29, 2008 (the "First Lien Security Agreement"), and recorded with The United States Patent and Trademark Office on February 11, 2008 at Reel/Frame No. 3717/0186, the Second Lien Supplemental Intellectual Property Security Agreement, dated January 29, 2008 (the "Second Lien Security Agreement"), and recorded with The United States Patent and Trademark Office on March 31, 2008 at Reel/Frame Nos. 3749/0439 and the Third Supplemental Intellectual Property Security Agreement, dated March 31, 2008 at Reel/Frame 3749/0552 (the "Third Lien Security Agreement", together with the First Lien Security Agreement and the Second Lien Security Agreement, the "Security Agreements"), ATP granted BONY a security interest in and to all of its right, title and interest in its trademarks and all applications and registrations therefor, including goodwill (the "Trademark Collateral");

WHEREAS, ATP has requested that BONY release its security interest in and to the Trademark Collateral, including without limitation the trademarks and all applications and registrations therefor set forth in Schedule A attached hereto and incorporated herein by reference.

NOW, THEREFORE, BONY, without recourse, representation or warranty and at ATP's sole cost and expense, hereby RELEASES all of its right, title and interest in and to the Trademark Collateral, including without limitation the trademarks set forth in Schedule A and any other collateral described in the Security Agreements.

BONY agrees to provide ATP with any information and additional authorization necessary to effect the release of BONY's security interest in the Trademark Collateral.

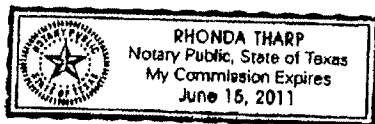


