RELEASE OF TRADEMARK COLLATERAL

(AMERICAN COMMERCIAL LINES LLC)

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of July 1, 2009, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity as the "Administrative Agent"), the secured party under the Security Agreement referred to below.

WITNESSETH:

WHEREAS, AMERICAN COMMERCIAL LINES LLC, a Delaware limited liability company ("ACL"), and certain other entities executed that certain Intellectual Property Security Agreement, dated as of April 27, 2007 (the "Security Agreement"), pursuant to which ACL granted a security interest to the Administrative Agent in certain trademarks and other intellectual property of ACL; and

WHEREAS, a Grant of Security Interest -- Trademarks executed in connection with said Security Agreement was recorded with the United States Patent and Trademark Office at Reel 003540, Frame 0374 on May 10, 2007; and
