AMENDMENT AND ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS

This AMENDMENT AND ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS, dated as of July 15, 2009 (this "*Assignment*"), is made by DEUTSCHE BANK TRUST COMPANY AMERICAS, as withdrawing collateral agent (the "*Withdrawing Agent*"), BANK OF AMERICA, N.A., as new collateral agent (the "*New Agent*"), and the Grantors listed on the signature pages hereto (collectively, the "*Grantors*").

WHEREAS, The Neiman Marcus Group, Inc., a Delaware corporation (the "*Company*"), the other Loan Parties, the Revolving Lenders party thereto, the Withdrawing Agent and the other parties thereto entered into that certain Credit Agreement dated as of October 6, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Existing Credit Agreement*");

WHEREAS, in connection with the Existing Credit Agreement, the Grantors and the Withdrawing Agent entered into (i) that certain Pledge and Security Agreement dated as of October 6, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Original Security Agreement*"), and (ii) that certain first Trademark Security Agreement, dated as of October 6, 2005 and that certain second Trademark Security Agreement, dated as of December 31, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Trademark Security Agreements*");

WHEREAS, pursuant to the Trademark Security Agreements, the Withdrawing Agent, as the original collateral agent, was granted a security interest in the Company's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreements) (the "*Security Interest*");

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office at reel 3176 frame 0629 on October 18, 2005, reel 3176 frame 0541 on October 18, 2005, and reel 3706 frame 0522 on January 29, 2008;

WHEREAS, the Loan Parties, the New Agent, the Co-Collateral Agents and the Lenders are entering into an Amended and Restated Credit Agreement dated as of the date hereof, which amends and restates the Existing Credit Agreement (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*");

WHEREAS, in connection with the Credit Agreement, the Grantors and the New Agent entered into that certain Amended and Restated Pledge and Security Agreement dated as of the date hereof (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*"); and

WHEREAS, (i) the parties desire to amend the Trademark Security Agreements according to the terms and conditions herein, and (ii) consistent with the Security Agreement, the New Agent is desirous of acquiring, and the Withdrawing Agent is desirous of assigning, all of the Withdrawing Agent's right, title and interest in, to and under the Trademark Security

Agreements, including, without limitation, the Security Interest, and all documents relating thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Withdrawing Agent, the New Agent, and the Grantors hereby covenant and agree as follows:

Section 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Security Agreement.

Section 2. Amendment of IP Security Agreements. Each of Sections 2 and 3 of the Trademark Security Agreements are hereby amended by inserting the words "and NM Nevada Trust" directly after the word "Borrower" and all references to the Company in the singular in such Sections shall be hereby construed in the plural to reflect the addition of NM Nevada Trust as a party thereto. The parties hereto hereby acknowledge that each reference in the Trademark Security Agreements and in this Assignment to "this Agreement" or "the Trademark Security Agreements", or words of like or similar import referring to the Trademark Security Agreements, shall mean and be a reference to the Trademark Security Agreements, as amended by Section 2 of this Assignment.

Section 3. Assignment of IP Security Agreements. The Withdrawing Agent hereby assigns, transfers and conveys to the New Agent all of its right, title and interest in, to and under the Trademark Security Agreements, including, without limitation, the Security Interest, and all documents relating thereto, including specifically and without limitation any lien on or security interest in all of Grantor's right, title and interest in, to and under the trademarks identified in Schedule I attached hereto and thereto, together with the goodwill of the business symbolized thereby, and all proceeds thereof. The New Agent hereby accepts the foregoing assignment.

Section 4. Recordation. The parties hereto authorize and request that the Commissioner of Patents and Trademarks of the United States and any other applicable government officer record this Assignment against the trademarks identified in Schedule I hereto.

Section 5. Security Agreement. The security interest assigned to the New Agent as the new collateral agent pursuant to this Assignment, has been granted in conjunction with the security interest granted pursuant to the Security Agreement, and the Grantors hereby acknowledge and affirm that the rights and remedies of the New Agent with respect to the security interest in the Trademark Collateral made and granted by the Trademark Security Agreements are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

Section 6. Counterparts. This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.


Section 7. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York.






